Process Overview

1 Intake / Eligibility Verification

Confirm eligibility with your regional B Lab office and complete the intake process, ensuring your company is ready for B Corp Certification and that expectations are aligned before moving into assessment.

2 Complete Self-Assessment

Submit your application for review. During this phase, SCS prepares for third-party assurance and identifies key areas to focus on during verification.

3 Assessment & Third-Party Certification

SCS reviews submitted documentation, verifies social and environmental performance, and ensures consistent application of B Lab standards. This phase may include clarification requests, interviews, and, where applicable, site visits.

4 Certification Issuance

Following successful verification, and after all Non Conformities **are being address**, SCS issues a B Corp Certification, confirming conformance with the B Lab Standards.

5 Ongoing Support & Re-assessment

SCS provides ongoing guidance to support continued compliance, performance **improvement**, and preparation for future B Corp recertification cycles.
