Definitions

Composting	Waste material diverted using composting (on-site or sent to a licensed composting facility), excluding residuals or contamination that is removed at any point in the diversion process, and sent to landfill.
E-Waste	Waste material sent to a licensed e-waste facility, excluding residuals or contamination that is removed at any point in the diversion process, and sent to landfill.
Landfilled	Waste material sent directly to, or removed at any point in the diversion process, and sent to licensed landfill or incinerated without energy recovery.
Prevention Through Redesign	Waste material which would have occurred under a former process that has since been eliminated or reduced due to redesign of the product, packaging, or process; this is only an internal diversion method.
Reclamation	Waste material that is collected and used as an input into a manufacturing process at the Certified Facility named on this certificate, resulting in a different use of the material as prior to it being designated as a waste; this is only an internal diversion method.
Recycling	Waste material sent to a licensed recycling facility, excluding residuals or contamination that is removed at any point in the diversion process, and sent to landfill.
Reuse	Waste material that is collected and used as an input into a manufacturing process at the Certified Facility named on this certificate, to be used for the same purpose as prior to it being designated as a waste; this is only an internal diversion method.
Sale	Waste material sold or donated to businesses or individuals, excluding residuals or contamination that is removed at any point in the diversion process and sent to landfill.
Waste-to-Energy	Waste material sent to a licensed waste-to-energy facility, excluding residuals or contamination that is removed at any point in the diversion process, and sent to landfill.
Zero Waste	99%+ of all waste material generated or prevented by the Operator, within the boundary of the subject under assessment.

Disclaimers

1. Hazardous waste that is required to be landfilled or incinerated by law is not included in the diversion calculation. However, hazardous waste that is diverted from landfill is included.
2. Waste stored at the time of the 12-month period audited shall not be included in the calculation but will be reflected in the following certified period.
