Expedited Certification¹

Organic certification typically takes between 12-16 weeks (60-80 business days) from application to certification. Operations seeking to obtain certification within a shorter timeframe are encouraged to register for expedited certification. - 2. Corrections will be billed as a new certificate request.
- 3. Labels must be of same general layout, design, and brand for bulk rate to apply.
- 4. Additional inspections may be required to process scope expansions (new land, facilities, processes, etc.) or may result from the necessity for increased surveillance of certified operations or for investigative purposes. Additional inspections may be announced or unannounced. This fee also applies to additional audit days for multi-day inspections.
