ISCC CORSIA certification verifies the sustainability, traceability, and greenhouse gas (GHG) performance of sustainable aviation fuels (SAF) and their feedstocks. Recognized by ICAO, it ensures compliance with the Carbon Offsetting and Reduction Scheme for International Aviation (CORSIA).

Achieving ISCC CORSIA certification allows operators and suppliers to demonstrate compliance with global aviation sustainability standards, track emissions reductions across the supply chain, and access international markets while supporting net-zero carbon goals for aviation.



Process Overview

Apply for Certification

1 Applicants submit preliminary operational information, and SCS provides a proposal detailing the certification scope, timeline, and costs for approval.

Pre-Assessment (Optional)

2 Review current systems against ISCC CORSIA requirements to identify gaps prior to the full audit.

On-site Audit

3 Operations are audited for ISCC CORSIA compliance, with findings documented in an audit report.

Complete Corrective Actions

4 Any non-conformities are addressed, with corrective action evidence submitted to SCS and follow-up verification conducted if necessary.

Receive Certificate

5 Approved companies receive a final audit report and ISCC CORSIA certificate, with documentation sent to ISCC.

Certification timelines can vary, with certificates typically issued a few weeks following completion of the on-site audit.
