#### Schedule the Audit

SCS will provide a work order for your review and signature. After the work order is signed, an audit will be scheduled during harvest. SCS will work with your team to schedule an audit that works best.



#### **Audit Plan**

The auditor will contact you in advance with an audit plan to provide your team with a timeline of audit day activities.



# **On-Site Audit**

A team meeting is required at the beginning and end of the audit. At the conclusion of the audit, the auditor discusses the audit results, including any non-conformities.



### **Corrective Actions and Technical Review**

Identified non-conformities must be addressed and evidence of corrective actions provided to SCS within the timeline set by the auditor at the end of the audit.



# **Certification Decision**

SCS conducts a final technical review of the audit report and Corrective Action documentation and makes the final certification decision.



# **Receive Certificate**

Congratulations on achieving GLOBALG.A.P. certification! A copy of your final report and certificate will be issued by SCS via e-mail. The GLOBALG.A.P. database will list your certification status.
