Global Recycled Standard

The Global Recycled Standard (GRS) is a voluntary product standard created by Textile Exchange for tracking and verifying the content of recycled materials in a product along a supply chain. The standard addresses traceability, environmental principles, social requirements, chemical content and labeling. The standard includes processing, manufacturing, packaging, labeling, trading and distribution of products made with a minimum of 20% recycled material. However, for a GRS claim to be made on a product, it must contain a minimum of 50% recycled content.

RCS certification provides alignment of recycled definitions across multiple applications, with materials verified to meet the ISO definition of recycled. It accepts both pre-consumer and post-consumer recycled materials.

Steps to Certification

1. Application, Scoping & Contract
2. Data Collection
3. Audit
4. Technical Review
5. Corrective Actions
6. Certification Decision & Certification Issuance
