Formal Independent Audit

Document Review

- Water withdrawals, discharges, consumption, and return flows.
- Evidence supporting water recovery, replenishment, or conservation claims.
- · Accounting models, baselines, monitoring protocols, and QA/QC procedures.

Data Validation

- · Assessment of accuracy, consistency, completeness, and traceability of datasets.
- Review of measurement systems and key assumptions.

On-Site or Virtual Audit

- Interviews with operational and technical staff.
- Confirmation of stewardship activities and benefit project implementation.
- Evaluation of governance, internal controls, and compliance.

Calculation Verification

- Recalculation or spot-checking of volumetric water benefit results.
